There will be site changes to the vendor area this year.

Vendors are expected to be set up and ready by 5:00pm on Thursday and remain open during carnival operations. Times are as followed:

Thursday 5:00pm – 10:00pm

Friday 5:00pm – 10:00pm (Special Needs Day from 11:00am-1:00pm and High School Graduation @7:00pm)

Saturday 12:00pm – 10:00pm (Grand Parade @11am)

Sunday 12:00pm – 4:00pm (please join us in a Free Community Breakfast @8am)

\*Special Needs Day is Friday from 11:00am – 1:00pm if you are interested in opening but it is not required.\*

**Spaces must be paid in full before May 1<sup>st</sup> to ensure you have one.** If I do not have your payment you do not have a space. If payment is made after the deadline you will be charged a late fee. **Payments MUST be received before you set up and you will not set up without checking in with Christa or Robin.** Check in will be in near the entertainment tent. **All early arrivals MUST be pre-arranged.** Fill out the 2025 Vendor application, sign application and rules stating you have read, understand and agree to abide by them and make checks payable to Mancelona Bass Festival (MBF) and send all information to:

The following rules will be strictly enforced:

1. No pornography, offensive language or rude gestures, no drug paraphernalia of any kind. **No alcoholic beverages maybe consumed during hours of operations.**

2. No selling of knives, guns, swords or any other type of weapon to anyone under 18 years of age. No selling of drug paraphernalia of any kind to **anyone.**

3. You are responsible for your own booth and area. Please keep your space clean and liter free.

4. You as a renter must supply your own booth, table, chairs, tents, electrical cords if needed ect. If you do not have a tent and wish to rent one you may contact BJ's Catering in Gaylord 1-989-792-4010. You pay them directly. We the Bass Festival Committee supply only the space.

5. If you have a problem please contact Christa at 231-342-3180

6. Food Vendors will be subject to Health Dept. Rules and Regulations. Due to our contract with the carnival certain foods cannot be sold by vendors. Please check with me for a list. **This year food vendors will be required to bring a generator. The Bass Festival will not be supplying electricity to food vendors as we do not have 220 amp outlets this year and limited 110v.**

7. **Spaces are assigned prior to opening day of the festival, there will be no relocation once assigned.**

8. **The Bass Festival Committee reserves the right to assign spaces based on site requirements and overall layout of Festival site.** The committee will review each application and limit the number of vendors with the same product.

If you fail to comply with the rules you will be asked to leave immediately with no refund.

9. Camping on some sites is prohibited. Antrim Meadows Campground is located at 764 E Elder Rd. Mancelona. You may contact them at 231-916-2493. Starlight Campground is located at 3060 Mancelona Road. You may contact them at 231-535-0461
